

# Is the Medication used in Intubation of Patients with Covid-19 Affecting the Outcome of the Patient's Treatment?

When the author received a WhatsApp phone call from her patient, saying that her son-in-law was in the intensive care unit being intubated during his treatment for a severe SARS-CoV-2 infection, and that he would make a final video call to his wife before he was intubated, it came to the author's mind what is missing in the kind of medicine that we are doing today in relation to this treatment of COVID-19 and also to the treatment of the most varied diseases today.

As demonstrated in the article wrote and published by the author (2021) entitled *Energy Alterations and Chakras' Energy Deficiencies and Propensity to SARS-CoV-2 Infection*, where she is explaining through the tree like figure that the symptoms presented by patients with SARS-CoV-2 are in the leaf level of the tree but there are alterations on the root of this tree, that is not seeing by the naked eyes, that has alterations in the energy level of these patients with SARS-CoV-2, that needs to be studied by the physicians and that is not addressed by the doctors nowadays, probably due to the curriculum offered by the medical schools in modern times. As everything is formed of energy before being transformed into matter, which we can see with the naked eye, very well explained in the book written by a physicist Fritjof Capra (1975) whose title of the book is *The Tao of Physics*, the author is explaining the different perspectives between the Western medicine and the oriental point of view in relation to all things that exists in our world. In this book, this author explains the transformation of energy into matter, including the energy of *Yin* and *Yang* and their relationship inside the human being and says and analyzes the duality of views between Western

and Eastern medicine, which today are considered different, but in fact, are the same thing seen from a different point of view. He emphasizes that the human being is a constant transformation of energy that can culminate in health or illness and all this thought are very close to what traditional Chinese medicine understand about the formation of health and how the disease is formed in the energy point of view. And as Western medicine is treating the symptom (in the leaf level of the tree) but caused by energy imbalances (in the root of the tree), described in many articles written by the author, in the most varied specialties, the problem of SARS-CoV-2 infection has been focusing only on the virus today and we are forgetting to treat the entire human being, that this patient could have some alteration that are facilitating the infectious process. So, even the use of medication to induce sedation in patients with SARS-CoV-2 could induce more energy deficiency, and could lead to more complications because all the internal functions of respiratory, urinary, circulatory and all the process needs energy. There are many articles published in the scientific community that the virus causes the most varied symptoms, but if we evaluate deeply, from an energy point of view, taking into account the energy changes of the patients that were found in her clinic in Brazil, we can understand that all complications generated by SARS-CoV-2, may be related to the type and medication we are using today, regardless of whether it is Hydroxychloroquine or Azithromycin or Ivermectin or corticosteroids, medication to treat fever, pain or even for sedation in intubation of these patient, well explained by Arndt Shultz Law. What is of interest now is whether the medicine the patient is receiving is highly concentrated or highly diluted because if the patient receives highly diluted medications to treat this infection, he will improve his vital energy, differently if the patient receives highly concentrated medications, that will worsen the vital energy leading to many other infectious and noninfectious complications. To know what kind of medication we should give, we must know what kind of patient we have today. And in her research, the author found that the majority of the patients nowadays has energy deficiency in the chakras' energy centers, which are responsible for production of *Yin, Yang, Qi*

Therefore, to hear that that young man, patient of about 30 years old, was being intubated and that for this he would be sedated and that he would have to use many highly concentrated medications to achieve a degree of sedation, the cascade of events with energy alterations came to mind, leading to a worsening of the energy necessary for the functioning of all its organs and systems.

This clinical worsening of these patients are usually said as if it were caused by the virus itself but in reality, it is very likely that it is caused by the type of medication received by the patient, being highly concentrated, widely used today to treat various diseases.

Could it be that the science we are studying today is leading us to the correct diagnosis of what is happening to patients or is it necessary to review the entire curriculum of medical schools that are teaching
