To fabricate a proficient civil service scheme, government must make certain that talented, competent and faithful persons are recruited in the civil service. But it is very untoward that sound recruitment system for civil service does not subsist in Bangladesh. Ensuring merit in public appointment is an imperative ingredient of worth civil service. Reservation of posts, politicization of bureaucracy and defective assessment system are destroying the reputation of recruitment and selection process to be a fair and echo system. If these procedures are transparent and unbiased then there is possibility to recruit brilliance human resources in our public services. And in this study it is like to find out the existing recruitment and selection process of Civil Service in Bangladesh, what is the key motive of BCS inclination in Bangladesh, their setback and also present some recommendation that how to get rid of these problems.

Firstly, BCS (Taxation) cadres has its own importance as the officials of their cadre work continuously to expanding the tax network and to collecting revenue for the government formulating relevant policies adopting different skills, techniques and pragmatism[2]. That's why most of the students want to exercise the power over the country and they feel more secure being a part of Bangladesh civil service because there are huge facilities are given to the civil servants in our country where they can lead a safe and certain life. The students are supposed to dedicate themselves to their academic study, but they are often found studying BCS materials in the library or reading rooms even from the very early days of their university life[3]. Let alone research work, a large number of students focus more on BCS related studies than their respective academia study. Bangladesh Civil Service all the more famously known by its abbreviation BCS, is the common help of the Government of Bangladesh[4].

The Figure 01 relating to age distribution of the respondent in the study area has been shown. It was observed that that the highest numbers of the people age were 20- 25.




Figure1. Age distribution of the respondent **Sex Distribution of the Respondent**




Figure 2. Sex distribution of the respondent

The survey Figure 03 was shows that 82% respondent were Yes while 18% respondent were No in the study area. I t is found figure that majority of respondent want to give BCS examination




Figure3. Interested in BCS exam




Figure 5. Causes of interest in BCS (Power)

Respondents expressed their opinion as they interested to get government job because of it gives social status, power, money, permanency and this job gives them the scope to work for country directly they can serve the people etc.

How can we come out from this inclination?

Most of the respondents said that the BCS system must be changed like as the question pattern, specialization and some have stated that we never come out if the government is not be moderated like politicization, lack of separation of power etc.

RESULT AND DISCUSSION

Who showed no interest among them some respondents wanted to go aboard, some were interested to do private job or some were frustrated .The main motive to sit for BCS exam is to hold power and money about 54% and wanted only money and only power is respectively the same about 14% and social status was about 16%. If they have chance to hold power then they wanted to hold power was about 86% and 14% never want to hold power. Some respondents who wanted to hold power thought it is the ultimate goal of desiring to be BCS cadre .They thought that power is the ultimate thing after achieving other thing like money, car, home, land and etc come automatically. Most of the respondents about 52% thought that the examination system of BCS was not innovative or productive and about 48% respondents disagreed with this. To select the cadre most of the respondents first gave priority on which cadre have more opportunities to earn money and power like police, administration and taxation rather than service and different BCS cadre like education, BCS agriculture, Ansar, BCS health and technical cadre get less priority because they thought this cadres have less scope to access power, money, opportunities and social status. Most of the candidates gather their experiences from society that there are four royal cadres in Bangladesh BCS that are the BCS Administration, BCS Economic, BCS Police and Foreign cadre.

RECOMMENDATIONS

- Government should stringently embark upon the mishandling of power and cultivate a sagacity to serve up the people and generate a sense that they are the servants of the republic and citizens are person over them.
- Above all, the government should make an effort to pledge one and the same rights and opportunity of every employee of government as well as private sector of Bangladesh by ensuring balance development and make sure that to serve up the people are the superior above all.
- The BPSC should give the real autonomy that would be able the BPSC to take action independently and make sure the recruitment of meritorious as BCS official. Corruption in evaluation and viva exam against them to uphold their image.
- A government needs to act out a down-toearth and encircling Civil Service Act that reflects the expectations of citizen without any disputes to provide service.
- Merit-based recruitment and promotion system in civil service is a must for a competent and energetic administration.
- The Government should set up a permanent pay commission that will update the salary of the public employees time to time taking the economic indicators of our country into consideration.
- This issue requires more research and examinations, so researchers, experts, and academician should come forward with more analysis and recommendations that can enhance the administrative wheel or research based organization of our country and also reduces the concept of misuse power.

CONCLUSION

In fine, it may be said, if we wish for to establish an impartial and well-organized civil service for the betterment of the nation, we have to implement the above recommendations. For
