The lyrics suggest that through communal activities, individuals can transcend their daily struggles and create moments of joy, reinforcing the idea that music can serve as a vehicle for emotional release and social bonding (Jiang & Sun, 2021).

In lines such as "Kissy face, kissy face sent to your phone," the song explores the paradox of modern relationships, where technology facilitates communication but often leaves individuals longing for deeper, face-to-face interactions. - While some critics might argue that this represents cultural commodification, the song can also be seen as a celebration of Korean culture. Through its playful lyrics and catchy melody, "APT" introduces an international audience to the communal joy and spontaneity of Korean social rituals, fostering crosscultural understanding and appreciation (Linden-Carmichael & Lau-Barraco, 2017; Doumas et al., 2022). The discussion surrounding cultural appropriation versus cultural celebration is complex, particularly in the context of globalized music. Critics often highlight the risks of commodifying cultural practices without acknowledging their origins, while proponents argue that such exchanges can lead to greater cultural appreciation and understanding (Borsari et al., 2007; Pennay et al., 2023).
